Pursuant to South Dakota Codified Laws (SDCL) 36-1C-6 and 1-26-20, in consideration of the above-captioned matter, and as the full and final resolution of this matter, the undersigned parties do hereby consent and agree to the following:

1. The South Dakota Department of Labor and Regulation, Cosmetology Commission (Commission) has jurisdiction over this matter pursuant to SDCL Chapter 36-15.
2. The Commission may take disciplinary action against a licensee on any of the grounds listed in SDCL 36-15-56, including under subdivision (2) the failure "of any person to comply with any of the requirements of this chapter or rules adopted pursuant to this chapter".
3. Disciplinary action may include suspension or revocation of an existing license or the refusal to issue a new license under SDCL 36-15-55.2.
4. SDCL 36-15-47 states that "Any apprentice licensed pursuant to this chapter may practice...under the constant supervision, control, and direction of a licensed instructor at all times..."

5. Savannah Thorne (THORNE) is licensed by the Commission as an esthetician (license number EO-13989) and esthetics instructor (license number IE-15664). THORNE has also been certified to offer eyelash extensions.
6. THORNE operates Lash Spa Boutique Apprentice Salon (APPRENTICE SALON) (license number ASL-11679).
7. On February 5, 2024, a Commission inspector conducted an inspection at the APPRENTICE SALON.
8. During the inspection, a Cosmetology Commission inspector (INSPECTOR) discovered that an apprentice was performing cosmetology services on a client without supervision by a licensed instructor. When questioned by the INSPECTOR, THORNE disclosed that her apprentices use call buttons to summon an instructor when help is needed, so that THORNE and other instructors in the APPRENTICE SALON are free to teach other students and apprentices or to go about salon business. THORNE also disclosed that an instructor is not present when an apprentice performs certain services on clients.
9. At the time of inspection, the inspector discovered that one of the instructors of record at the salon had an expired license.
10. THORNE is the owner and operator of the APPRENTICE SALON and is responsible for the salon's compliance with Commission laws and rules.

11. On April 17, 2024, a complaint in this matter was filed against THORNE based on the above allegations.
12. The above-described conduct constitutes grounds for discipline pursuant to SDCL 36-15-56(2) with reference to SDCL 36-15-47 and 36-15-47.1.
13. THORNE is aware of and understands the nature of this matter. THORNE acknowledges that she has been informed of various rights she has in this matter. These rights include, but are not limited to, the right to:
 - a. be represented by a lawyer in this matter;
 - b. receive notice of any hearing in this matter;
 - c. have a contested case hearing, as defined in SDCL 1-26-1(2). A contested case hearing includes the right of the THORNE to be present at the hearing, be represented by legal counsel, introduce evidence, present testimony, call witnesses to testify, cross-examine all witnesses present, and submit argument on her own behalf; and
 - d. appeal any decision based on the contested case hearing to circuit court and the South Dakota Supreme Court, as provided by law.
14. THORNE agrees that, by signing this Consent Agreement, THORNE voluntarily **waives** all of these rights, procedures, and proceedings before the Commission. THORNE further waives any other rights to which she may be entitled under state or federal law as applicable to this matter.
15. THORNE is not represented by an attorney in this matter.

16. THORNE understands that by entering into this Consent Agreement, the Commission is making a finding that THORNE violated SDCL 36-15-47 and 36-15-47.1. In addition, THORNE understands that by entering into this Agreement, the Commission is taking formal disciplinary action against THORNE and her APPRENTICE SALON.
17. In return for THORNE's agreement to the provisions of this Consent Agreement, the Commission agrees not to proceed to formal hearing in this matter and agrees that this Consent Agreement shall constitute the final Commission disposition of this matter.
18. THORNE agrees that this Consent Agreement shall serve as the final resolution of this matter, including any appeal. THORNE also agrees, in lieu of further contesting this matter, that:
 - a. THORNE shall pay a fine in the amount of **\$350**, due to the Commission office within 30 days of the effective date of this Consent Agreement.
 - b. THORNE and the APPRENTICE SALON shall not enroll new apprentices for a period of **180 days** from the effective date of this agreement.
 - c. THORNE shall take and pass the South Dakota Cosmetology Laws and Administrative Rules Examination for Instructors within 15 days of the effective date of this agreement.
 - d. Within 15 days of the effective date of this agreement:

- 1) THORNE shall remove all call buttons from apprentice workstations, the use of which does not satisfy the requirement for constant supervision of an apprentice by a licensed instructor.
 - 2) THORNE shall provide the Commission executive director with a plan to ensure the constant supervision of apprentices by a licensed instructor, regardless of the services being performed by the apprentices. The executive director shall review the plan to determine if it complies with the provisions of SDCL 36-15-47. If the plan is compliant, the executive director shall approve the plan and append it to the APPRENTICE SALON's curriculum.
- e. THORNE shall comply with all provisions of SDCL Chapter 36-15 and ARSD Article 20:42 during the pendency of this Consent Agreement.
19. This Consent Agreement shall be deemed complete upon THORNE's compliance with the terms of the agreement, and the Commission office shall provide THORNE with written verification that the terms of the agreement have been completed by email at THORNE's email address on file with the Commission.

20. If THORNE fails to comply with any of the terms of this Consent Agreement, THORNE agrees that any such violation would constitute new grounds for further discipline.
21. THORNE understands and agrees that the terms of this Consent Agreement shall be public.
22. THORNE consents, agrees, and acknowledges that this Consent Agreement must be submitted to the Commission at a public meeting for acceptance or rejection. If the Commission rejects this Consent Agreement, THORNE waives any right to claim prejudice or to request recusal of any Commission member by reason of any factual basis submitted to the Commission in an effort to resolve this matter by Consent Agreement rather than by formal proceeding.
23. THORNE understands that nothing in this Consent Agreement will be deemed to restrict the Commission from raising facts in reference to THORNE outside of those set forth in this Consent Agreement, if there are other material facts related to the matters under investigation that have not been set forth or disclosed herein.
24. THORNE understands that this Consent Agreement may be considered in any future licensing matters with the Commission and for the purposes of determining the appropriate sanctions in any future actions by the Commission for any violations of laws or regulations of the State of South Dakota or for failing to abide by any order or decision of the Commission.

25. THORNE has read, understands, and agrees to this Consent Agreement and is freely and voluntarily signing it. This Consent Agreement contains the entire agreement between the parties relating to the matters referenced in the Consent Agreement. THORNE is not relying on any other representations of any kind, verbal or otherwise.
26. THORNE agrees to waive any rights and procedures afforded her under SDCL Chapters 1-26, 36-15, 36-1C, and ARSD Article 20:42.
27. This Consent Agreement shall be effective on the date it is signed by the Commission member designated by the Commission.
